- RULES & REGULATIONS -

General Rules

- Passholders and their guests shall abide by all rules and regulations of Apple Mountain.
- Play on the course is governed by USGA rules, with the exception of local rules, which take precedence.
- The Board of Directors, General Manager, Director of Golf, Head Golf Professional and Golf Course Superintendent are empowered to enforce all golf course rules.
- It is the policy of Apple Mountain to play foursomes. Twosomes and threesomes will be paired whenever possible. Two carts per foursome only.
- Pass holders must register at all times in the Golf Shop before beginning play. Violation may result in pass forfeiture.
- "Cutting-in" is not permitted at any time. Play must only be commenced at the first hole unless otherwise permitted or instructed by the Head Golf Professional or golf staff.
- Practice is not allowed on the golf course. The practice range, if available, and the practice putting greens should be used for all practice.
- Cancellation of tee times must be made at least 24 hours in advance of play. Pass holders may be assessed a \$25 per tee time "no show" fee.
- Passes are not valid for organized play.
- Pass fees are non-refundable and non-transferable.
- A pass is not an investment, nor does it provide any equity or ownership interest in Apple Mountain.
- Weekday passes are valid only after 12pm on Memorial Day, Independence Day and Labor Day.

Golf Cart Usage

• The use of golf carts is mandatory. The golf cart (hereinafter referred to as "property") is hereby leased from Apple Mountain for the number of holes of play on the date of play. Said property is not to be removed from Apple Mountain and is to be returned promptly after use. The passholder will keep said property in their custody and not sub-lease or re-rent the same. The passholder will keep said property in the same condition as when received. The passholder will not hold Apple Mountain or any personnel of Apple Mountain responsible for any accident or injury that may result to themselves or others through the use of this property. Apple Mountain is not responsible for articles lost while on premises. A driver's license is required to operate golf carts. Any damage incurred should be reported immediately to the golf course staff.

Charge Privileges

- Passholders are required to have a valid credit card on file as well as a current photo.
- House Charge privileges are provided complimentary to passholders and are valid throughout the resort.
- All passholders will receive an identifying account number and that account number must be provided at the time of purchase when applying charges to that account. Account numbers are non-transferable.
- All food, beverages, merchandise & services billed to an account will automatically be charged against a secured credit card. Statements are made available monthly. Individual receipts will not be provided with monthly statements.
- A late fee of \$25 will be assessed to all accounts not paid in full by the 15th of each month.
- Apple Mountain must be notified immediately if the credit card on file is compromised.

Locker Rental

- One locker is available for lease per pass. Locker assignment will be made on a first-come, first-serve basis.
- Lockers are available only during golf season, approximately mid April to mid November.

Food and Beverages

- All food & beverages consumed at Apple Mountain must be furnished by Apple Mountain.
- Michigan law mandates that all alcoholic beverages must be purchased from Apple Mountain.
- Personal coolers are not allowed on the golf course.

Guest Privileges

- Guest rates are valid only during applicable passholder days/hours.
- Passholders must accompany all guests receiving a discounted rate for golf.
- Passholders are responsible for all charges and actions of their guests.

Driving Range

- Passholders may purchase bags of range balls for ^{\$}5 per bag for their use; bags purchased for guests may be purchased at the rack rate.
- The driving range is open during normal Golf Shop hours; the range may be closed from time to time for general maintenance, events or at the discretion of management. Range balls are to be used on the driving range only and are not to be used on the golf course and/or taken from the range to the Golf Shop area.

Resignation, Suspension and Termination of Golf Pass Rights and Privileges

- Apple Mountain may suspend or expel a passholder, family member or guest for cause or non-payment of house charges at its discretion. Any person expelled will immediately and automatically forfeit all pass privileges.
- Apple Mountain reserves the rights to discontinue offering any category of golf pass and/or create additional categories, as it deems appropriate. Passholders will be notified in writing of all changes and amendments to the rules and regulations.
- The decision of the Board of Directors of Apple Mountain shall be final on all questions involving the interpretation or construction of the rules and regulations set forth.
